# JCICS Board Meeting June 28, 2006 In Person

Call to Order & Agenda: R. Gibson at 8:33 AM EST

**Introductions & Overview of Board Operations:** M. Hendy & R. Gibson

An overview and refresher of board duties and the knowledge based governance approach as previously presented by Tecker Consultants were discussed.

Discussion was held about member feedback regarding the strategic plan and doing an annual survey with targeted questions to keep a pulse on member perspectives.

Jessica Clark is no longer with JCICS. Two interviews to fill the position have been conducted and a third is scheduled for Thursday. The hope is to have someone hired by July or August. Since the position is not entry level, it may require additional funding.

L. Wetterberg MOVED/ K. Wallace SECONDED PASSED Unanimously

Mega Issue: With the membership initiative failing to pass in April, is this an issue the Board would like to revisit? Is this plan the best way for JCICS to reach its goals as outlined in the strategic plan and spend its energy?

Article IV – Membership

Original Wording:

The corporation shall consist of organizational members.

Organizational membership shall include any non-profit North American organization or US licensed, non-profit agencies that directly or indirectly arrange for intercountry adoption placements; or provide pre-placement or post-placement services; or provide adoptive parent support services, that are concerned with international adoption, or provide services to children in countries other than Canada and the United State. Each member organization shall have one vote.

# **Proposed Wording**

(Part 1) Organizational membership shall include any non-profit organization that provides permanency services for children, including but not limited to, adoption agencies and home study or post-placement service providers, adoptive parent support groups, medical clinics providing services to internationally adopted children and their families, and child welfare advocacy organizations focused on permanency for children. Each member organization shall have one vote.

(Part 2) An affiliate non-voting status is permitted as approved by the Board of Directors.

#### Rationale:

Part 1 - By clarifying the organizational membership section in the bylaws and expanding eligibility to organizations outside of North America, JCICS will be able to continue our existing structure while ensuring JCICS is a global entity with representation in various countries.

Part 2 – Creating an affiliate non-voting status will allow individuals to join JCICS demonstrating their commitment to the mission and cause of permanency for children. This would allow students, retired agency professionals, and for-profit entities to join at an affiliate level receiving fewer benefits than the core organizational membership, but still affording them an opportunity to be involved in the organization. More detail and criteria would be explained in the Affiliate Membership Policy.

Discussion was held that the bylaw change did not pass because not enough people voted. It required 66% approval to pass, but only received 60% approval. Feedback at the business meeting requested that under Part 1, the phrase "including, but not limited to" be removed, to clearly maintain the core membership.

MOTION: Whereas the BOD of JCICS desires to be consistent with its strategic plan; and whereas JCICS seeks to expand its ability to advocate on behalf of children; and whereas JCICS desires to diversify revenue sources to broaden its collaborative reach, be it therefore resolved that the proposed wording of Article IV – Membership be changed to:

(Part 1) Organizational membership shall include any non-profit organization that provides permanency services for children, whose goals and policies are consistent

with the JCICS mission and values, including adoption agencies and home study or post-placement service providers, adoptive parent support groups, medical clinics providing services to internationally adopted children and their families, and child welfare advocacy organizations focused on permanency for children. Each member organization shall have one vote and be entitled to full membership benefits.

(Part 2) An affiliate non-voting status is permitted as approved by the Board of Directors and will have affiliate benefits.

Complete by August 15<sup>th</sup> so membership can complete vote by September 8<sup>th</sup> and everything will be in place for the fall membership drive.

Mega Issue: How can JCICS prepare for the unexpected and ensure that an unforeseen leadership transition is handled as smoothly as possible and will help JCICS become even stronger?

Meghan attended workshop that addressed succession planning put on by Transition Guides. She will request that the company draft an RFP to present this topic to members at the next annual conference.

A sample Emergency Succession Plan from the Center for Nonprofit Advancement was reviewed. Meghan & Rick will fill in the blanks for future board review and will check it against the current policies and procedure.

Meghan's maternity leave plan was reviewed.

#### **Financial Report:** L. Vollman & M. Hendy

Two sets of financials were reviewed, one from January 1, 2006-May 31, 2006 and January 1, 2006-June 23, 2006.

Meghan spoke to auditor about having \$100,000 in Bank of America. For a specific account it is not best practice, but given the security of this bank it will be left as is.

#### Children's Charities for 2006

JCICS is a part of Children's Charities, which is a Federal workplace giving program. A few years ago JCICS' operating name was changed to Adoptions International – Joint

Council. JCICS used to take in about \$3,000 and now takes in \$15,000-\$16,000. A large portion of the donors were US staff overseas.

The cut off for the percentage of the budget allocated for administration is 25%. JCICS' 990 form for 2005 reflects that administrative costs were 28%. JCICS will apply again this year in July/August, but to receive funds the Office of Personnel Management must approve an exception for this year. The JCICS' auditor may have misallocated some budget items under administrative that were misappropriated. He offered to do an amended 990 and was requested to write a letter to Children's Charities to explain the budget categorizations. Meghan recommends that JCICS find a new auditor as discussed in the past for best practice. The BOD should be aware that this will cost about \$5,000 more.


# Fundraising Report: Reynolds & Rowe




UPDATE: DHL Express – Audit is complete and over 55 members needed to be recoded.

Of the 77 JCICS members signed up, 55 were improperly coded due to human error. 8 old members were removed from the benefit list, and the 55 will receive cash reimbursements. Members can receive up to a 40% discount. Staff investigated a Fed Ex discount, but they rejected the proposal.


Jennifer has been reaching out to the largest JCICS members this week to ask what benefits would be most helpful to them to make their membership worthwhile.



#### <u>International Relations Update</u>

Tom mentioned the possibility of free office space in Moscow and Kiev. It is unclear who would staff it and what the purpose of it would be at this time.

#### GAC: Documentary Film Proposal

Film maker in NY who is an adoptee was interested in making a film. She has since changed direction and is making a film on the Vietnam Baby Airlift so this proposal will not move forward at this time.

# Romania: L. Wetterberg

Concern was raised over negative adoption language in news articles where adopted children are referred to as "exported". Discussion was held about a JCICS press release to address this.

Discussed approaching local film schools to produce a short video addressing common adoption myths.

# **Utilizing the BODs Expertise & Traveling to Other Countries:** R. Gibson & R. Pearlman

#### China

Recommend that Snow Wu be the go-to person to run by communications with the CCAA. It would be helpful to have her be the JCICS liaison as she understands Chinese culture.

Discussion was that the Board already does this.

**Country Updates: BOD** 

Guatemala Proposal: R. Pearlman & L. Wetterberg

Proposed Outline for JCICS Role in Assisting Guatemala in Becoming Hague Compliant

- 1) JCICS representatives designated by Board, simultaneously confer with:
  - a. CIS officials and.
  - b. DOS officials

To discuss and confirm the steps noted officials above think Guatemala needs to take in order to be in compliance with the Hague.

- 2) Discuss with CIS and DOS the possibility of JCICS acting as an NGO in cooperation with CIS and DOS to consult with Guatemalan stakeholders regarding the exploration of measures they can take that would assist Guatemala in making their adoption process Hague Compliant.
- 3) Integrating the information culled from items #1 and #2 above, draft a memo addressed to select Guatemalan government officials, PGN officials, select lawyers, and select facilitators offering the services of JCICS as a consultant, for no fee, regarding Hague compliance.
- 4) Meet with key Guatemalan stakeholders to facilitate discussion and map out a plan designed to assist Guatemala in developing structures and processes that would be acceptable to CIS and DOS and allow the adoption process in Guatemala to continue following US ratification of Hague.
- 5) JCICS Consultation would include facilitation of small and large group seminars/meetings with the purpose of achieving stakeholder "buy-in" and would include assistance with fostering implementation of ideas generated by Guatemalan stakeholders.

#### **IMPLICATIONS:**

- Who designates Guatemalan stakeholders who will be asked to take part in discussions?
- What will be the roles of the Guatemalan Caucus, Caucus Co-Chairs, Board and Staff regarding the Task Force?

Discussion was held regarding the practicality/logistics of the above ideas. Further discussion will be held after meeting with the DOS on June 29, 2006.

#### **ICARE Discussion:**

On Tuesday June 13, Meghan and Jennifer met with Nash Molpus, Office of Senator Mary Landrieu, Brooke Roberts, Office of Senator Larry Criag, and Kimberly Gluck, Office of Senator Jim DeMint to discuss the ICARE Amendment which was drafted by their Senators. This Amendment serves to establish an Office of Intercountry Adoptions within the DOS and to reform laws governing intercountry adoptions in the US.

The ICARE Amendement, S.AMDT.4025 was agreed to by the Senate by voice vote and thus added to the Immigration Reform Bll, S.2611 which was passed by the Senate. The Co-Sponsors of ICARE are Senators Mary Landrieu, Sam Brownback, Tim Johnson, and Jim DeMint. S.2611 will eventually be sent to a Joint Committee of House and Senate for mark-up. This committee will most likely be members of the Judiciary Committee. The House has asked for further hearings on the Bill and the prospective S.2611 going to committee for negotiations before September is unlikely.

JCICS discussed our concerns with ICARE in the meeting. Major points of concern are:

# 1. Timing

With the final regulations issued in February by DOS, the US' Hague implementation is currently proceeding. JCICS believes that the Office of Children's Issues has undergone significant improvements over the past few years and has increased staffing and attention to Hague Implementation and intercountry adoption in general. JCICS is concerned that at the present time, the introduction of ICARE would impose broader and more complex changes to the intercountry adoption process. JCICS would prefer to have the US ratify the Hague Convention and assess at that time how the DOS is performing as the Central Authority and whether additional reform is needed. There is apprehension that this new legislation would impede the Hague process and cause more complication and further delay to the implementation of the Hague.

#### Senate Offices Rebuttal

They recognized that the timing may not be the most favorable; however, Congress has only few opportunities to strategically pass legislation. They hope JCICS will recognize the safeguards for children and necessary reforms in this bill and the need for it to pass. They acknowledged JCICS' concerns over timing and said that the timing in the text of the Amendment, which states this must take place in 180 days, could possibly be revised so as to not impede upon the full implementation of the Hague. They stated their concern that if this is defeated in committee now due to lobbying efforts, it will be very difficult to pass such reforms in the future, when they will be needed. They shared that if time is JCICS' main concern, they can make changes to the implementation of the Amendment. They vehemently agreed that they are against any complications or postponement of the

Hague implementation due to the ICARE legislation They stated that they would ensure this would not happen.

# 2. Funding

The Senate Offices shared that all funding allocated to DHS for their adoption processing would be moved to DOS. They assured JCICS that there would not be a lack of funding, as all resources would be moved from the other agencies working on adoption to DOS. Any additional funding needed would be garnered through the Appropriations Committee on which both Senators Mary Landrieu and Sam Abrownback sit.

In closing, the Offices shared that if JCICS has any substantive concerns with the language of the legislation, JCICS should share them with the Senators and they would discuss potential revisions.

# JCICS ACTION PLAN:

- Should JCICS review the ICARE legislation and submit any substantive changes to the Senators for review?
- Does JCICS go to additional offices, perhaps on the Judiciary or Appropriates Committees to lobby against this legislation? *This could potentially cut ties with* Senators offices that drafted and support this bill (Landrieu, Craig, Brownback, DeMint, etc.)
- Does JCICS maintain its current stance and continue to watch the legislation for the time being and discuss major actions once JCICS has a better idea of how the legislation is moving in the future?

Discussion was held that if the Immigration bill does not pass ICARE may be tacked onto another bill yet again. It has passed both the House and the Senate, but as two separate versions. Most likely the Judiciary Committee will modify it into one bill to be signed by the President. If it does not go to committee until September, given that a new Congress takes over in November, it is unlikely that it will be modified by then.

The board will re-read the legislation and further discuss tomorrow.
