CEO Report: T. DiFilipo

Fundraising

Tom and Joelle are heading up current fundraising efforts. Efforts are focused on obtaining 2008 conference sponsorships. An email will be sent shortly to approximately 5000 adoptive families with an update on Guatemala that will contain a light appeal. JCICS has received \$5,000 in unsolicited donations since the Guatemala 5000 initiative began.

Conferences Attended

Tom spoke at the CARA conference in India as well as the Adoption Ethics conference in the DC area. Tom also served on a panel at the Ethics conference with UNICEF representatives Manuel Manrique and Kelly Bunkers, as well as adoptive parent and journalist Elizabeth Larson. Joint Council has been invited to speak at the Ministry of Education Adoption Conference in Moscow during the first week of December.

<u>International Relations Initiative</u>

India

Joint Council is working with CARA & DOS on a few Hague pieces to be clarified. Joint Council will also be submitting written comments on the new regulations taking effect in 2008.

Africa

Joint Council is collaborating with Mark Moore, a specialist for Senator Landrieu who is well connected in Africa. The trip to Africa was cancelled due to logistical reasons and has been postponed until January or February of 2008.

Vietnam

Joint Council will be holding a mini-summit in DC during the last week in November. It will include caucus agencies, non-member agencies and representatives of DOS & USCIS. Mr. Dao from the DIA in Vietnam will be invited to come and address ongoing concerns with practice levels, corruption and the renewal of the bilateral agreement which expires in June 2008 and must be renewed in September 2008.

Russia

Joint Council is working with a few members of congress & CCAI to leverage the DOJ to pressure Interpol to issue clearances for agencies waiting for approval since July.

Columbia

During the trip, Tom visited several children's homes and reviewed new regulations with Bienestar. A meeting was also held with the Assistant Attorney General for Children's Rights. A Columbia caucus has been formed and will be having a conference call to discuss difficult provisions within the new regulations. (eg. Adoptions for Columbian nationals are to be free of charge)

Guatemala 5000

Joint Council was instrumental in having a letter from 203 members of Congress be sent to President Berger, UNICEF in Guatemala & NY. Joint Council is working with DOS to help them understand the proposal and support it along with the Hague Permanent Bureau. It should be officially introduced into Guatemalan Congress next week.

Staffing Update

Jennifer originally planned to come back from her maternity leave p/t in October and then f/t in November. Due to health complications with the baby she has returned very p/t and intends to return f/t; however the exact timeline is not yet known. Additional interns have been secured to help with manpower in the office during this time.

Membership Drive 2008: A. Schlicht

Membership applications will be available no later than two weeks from now. A copy will be sent to all current members with the newsletter. Membership fees will not change

this year. Efforts are underway to reach out to 40 new organizations that have never been recruited in the past. It is hoped that next month an additional outreach effort will be launched to identifying & collaborate with the licensing bureaus in all 50 states.
