215. *Malik Shakir Bashir Awan:

Will the Minister Incharge of the Prime Minister's Secretariat be pleased to state:

(a) the province-wise total amount of funds released for development projects launched during the years 2008-09 under the Prime Minister Programme; and

(b) the total number of schemes completed out of the said funds?

Minister Incharge of the Prime Minister's Secretariat: (a) An amount of Rs.28000.0 million has been allocated from the People Works Programme-II (PWP-II) since 1st April 2008 to 30th June, 2009 for the development schemes of MNAs as under:—

All persons found involved in the cases were either convicted and awarded sentenced ranging from six months to ten years or with fine or both OR they are facing trial in the competent courts. Proceeding of some of the important cases are mentioned below:—

1. Case FIR No. 613/09 dated 14-10-2009 U/S 3/4 PACHTO, P.S. AHTC, Rawalpindi

On receipt of information from US Embassy Islamabad, an enquiry was conducted and subsequently case was registered by Anti Human Trafficking Circle, Rawalpindi, against accused (1) Afzal Masih S/o Walayat Masih Padree, R/o Islamabad, (2) Sadeem Masih S/o Qamaruzzan R/o Faisalabad, (3) Tariq Masih S/o Samuel Masih, R/o Faisalabad and (4) Saleem Masih S/o Dilawar Masih, Faisalabad, who were involved in illegal trafficking of child Miss Marina D/o Tariq Masih to USA. Challan of the case has been submitted in the relevant court.

Case FIR No. 215/2009 U/S PACHTO 2002 P.S, AHTC, Karachi.

This case was registered against Yasmin Ahmad W/o Ahmad R/o Karachi and Nasima Aslam D/o Aslam Pervaiz R/o Karachi, for their illegal journey to Oman, involvement in prostitution and sexual exploitation. Accused Yasmin Ahmad A has been awarded ten years imprisonment.

Case FIR No. 170/09 U/S PACHTO 2002 P.S. AHTC, Peshawar.

On interception of a Saudi national at Peshawar airport, who had married with a Pakistani girl aging ten (10) years, this case was registered. Accused persons were acquitted by the court.
