Detective Torres reports that on November 17, 2010, he received a report of child abuse relating to a video broadcast on the "Dr. Phil" television show depicting Jessica Beagley punishing her child, K.B. The undersigned has viewed the video in question and observed Jessica Beagley forcing K.B. to swish hot sauce in his mouth while yelling in his face and then forcing him to stand confined in a cold shower while she yelled at him. The video has sound and anyone watching the video can hear K.B. screaming in pain. Detective Torres gathered evidence from interviews conducted with Jessica Beagley, her husband, and her six children. The undersigned has reviewed all evidence obtained from Detective Torres investigation and based on that evidence the discipline inflicted on K.B. was not reasonable pursuant to AMC 8.10.030.E.
