First I would like to say Happy Holidays to you , your Family , and staff , we know it is January 16, 2008 but we did not want to bother you during the Holidays. Governor Crist the reason I'm writing to you again is to THANK YOU for finding the time to read my letters. After my second letter to you we saw hope regarding our situation. To keep you up to date,

On 11/28/07 Judge Valerie Manno-Schurr and Mr Neumann walked right in front of us as she took the children into her chambers by herself and Mr Neumann, during the 40 minutes that they were in the chambers with the children, the children were only asked 3 questions, the rest of the time the Judge Manno-Schurr and Mr Neumann were talking with each other while the children were playing. When they came out of her chambers Judge Manno-Schurr acted like she didn't remember too many details about the case, and after 40 Minutes alone with the children and Mr. Neumann the best that Judge Manno-Schurr could come up with was that the children were hyper and ordered another evaluation and this would be evaluation number 6. Obviously they were not there to talk to the children , because Mr. Neumann had already been to the school and the principal provided him with a room alone with the children for the entire lunch time were he proceeded to interview them, the questions he asked them were very upsetting ,when we picked-up the children from school they told us everything. **IF THE INTERVIEW WITH JUDGE MANNO-SCHURR HAD BEEN DONE THE RIGHT WAY AND IT HAD BEEN RECORDED OR A THIRD PARTY HAD BEEN ALLOWED TO BE PRESENT IN THIS MEETING THIS CASE WOULD HAVE BEEN DONE AND OVER WITH.** The next hearing is on February 01 2008

Governor Crist we didn't started this situation WE WERE HOME RAISING OUR CHILDREN WITH LOVE, AS ANY FATHER AND MOTHER WOULD DO., all this started when we found out what the GAL representative wanted to do. He wanted to send them to Texas knowing very well that the father who was found guilty of two felonies of child abuse , could take a plane and move to Texas at any time, and no one seemed to care, as a mother and father what are we suppose to do?. We did what any parent would do for their children. we stood-up for them to protect them.

We are writing to Senator Ronda Storm who is the chair person for Children, Families and Elder Affairs, and enclosing copies of all the letters that we mailed to you.. This family case has been so mishandled, it has turned into a Civel Rights issue, and we are informing this to Mrs Storm.

Thank You again Governor Crist to you and to your staff we are very grateful also we would like to thank you on behalf of our children and our family , and hopefully the next time we write to you it will be to let you know that we have finalized the adoption.

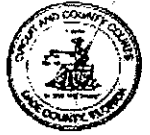

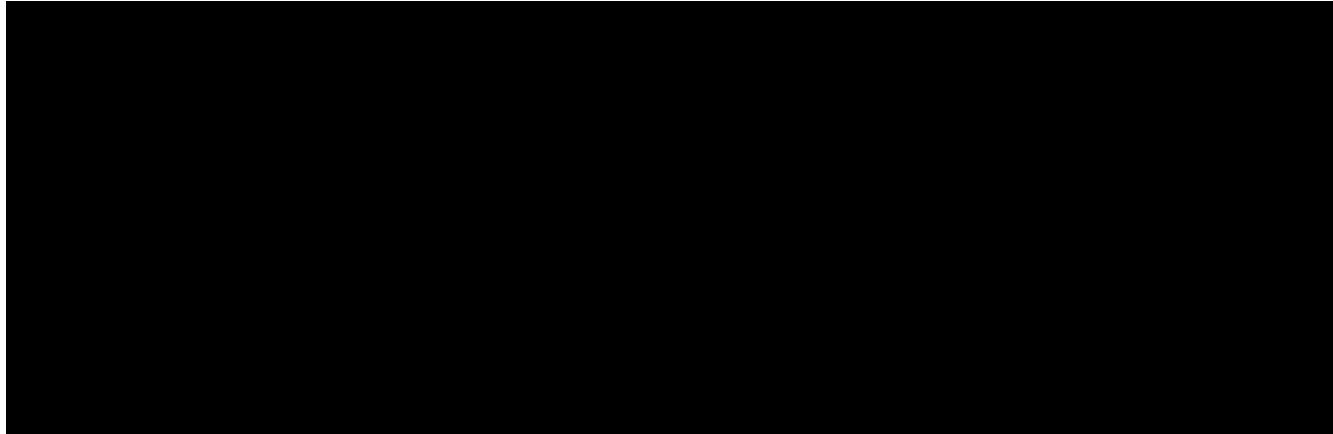

This is the case where Dr Ditomaso gave the false report that the children did not remember.

The GAL representative Mr Paul Neumann, and the GAL attorney were both in this hearing and knew that Dr DiTomaso was giving a false report. In fact Mr. Neumann was also present at the deposition at the state attorney office where the children were very detailed regarding what their father had done to them the GAL representative insisted so much that they had the relatives on the phone all the way from Texas, that Judge Prescott had to tell them that he was only there for the issue at hand , that they had to go back to family court for anything else.
