MPA curriculum undergoes major revision

Beginning with the Spring 2009 semester, the MPA program curriculum undergoes major changes to better comply with new NASPAA guidelines emphasizing evaluation and curriculum improvement.

A curriculum sub-committee consisting of MPA faculty and three Community Advisory Board members reviewed the MPA courses and submitted suggestions for changes that will not affect students who entered the program before the Summer 2008 term.

Students who entered the program in summer or fall 2008 and have completed PADM 6500 Research Methods, will not be affected by the changes. Students not previously enrolled in PADM 6500 will graduate under the new curriculum.

The courses in communications, ethics, intergovernmental relations and state government and administration have been eliminated from the program, although ethics will be included as discussion topics throughout the program.

The capstone will remain, but proposals for the capstone will be developed in PADM 6500, the research methods class which will be the immediate predecessor of the capstone course. Instead of working on a group project, students will develop proposals for the capstone course.

Some courses were renamed and/or renumbered. PADM 6250 became Urban Planning; and PADM 6400 is now Managing Nonprofit Organizations, an introductory course in managing nonprofits.

Positive responses from students who participated in "special topics" on comparative resulted in the new PADM 6800 Comparative Public Administration.

Research Methods PADM 6500 is now a lab course with an additional 14-16 hours of instruction in SPSS (changing it from a 3-hour to a 4-hour course).

Committee studies MPA application requirements

The sub-committee also took an in-depth look at the admissions requirements for the program,

and dropped the American Government prerequisite because they felt it served no useful purpose.

The committee is still reviewing the application process and may announce further changes this spring.

Career Center assumes responsibility for internships

Changes to the internship procedures began with the Fall 2008 semester. Career Services now interviews and matches students with appropriate internships in line with MPA requirements. Dr. Ralph Walker will continue to make site visits to the internship locations and supervise academic requirements for completing PADM 6900.

Former Advisory Board member adopts Guatemalan children

Scott Dean, former Mayor of Harlem, GA, stepped down from the MPA Community Advisory Board this past year, in order to devote more time to his rapidly expanding family. First there were two — now there are SEVEN children in the Dean household! Five are siblings adopted from Guatemala as a group to keep the family

from being divided. It took three years, dozens of plane drips and more than \$10,000 in adoption fees. but, Scott and Renee Dean were committed, and on Sept. 19, the Harlem couple flew back with five new family members who had been living in an orphanage in Zacapa, Guatemala: siblings Marlin, 15; Silda, 14; Sindy, 11' Mimi, 6; and Byron, 4. On a mission trip to Guatemala four years ago, Scott met two very special little girls, "The spark that they had was amazing. It just really drew my attention," he says. When he went back a year later and saw them again, he felt led by God to bring them home with him. But surprise, surprise — there were three more siblings, so the Scott

family of four became a family of nine. However, it was not an overnight process. It took three maddening, roller-coaster years of airline flights, adoption papers and red-tape.

"I just really felt led to do this. I just really felt a calling," says Scott.

Scott estimates that he spent a total of six months in Guatemala, including the final 31 days. He had to lay the groundwork at the orphanage, then camp out in Guatemalan officials offices for days on end. At one point he asked an official how long a particular piece of paperwork would take, and was told "two weeks." He told the woman that he would be in her office every single day of that, and might even accompany her to lunch.

Voila! The paperwork was completed much sooner than expected! But none too soon for the former mayor who is now District 4 Columbia County commissioner. Within the span of only a few hours, the ordeal could lift his spirits to the heights, then rules would change and he would crash back to reality. Bureaucrats on both ends of the process were amazed by Scott's determination. "We took it as a calling," says Scott. "That's what people of faith do - no matter what it takes, or how long it takes."

The Dean family received much support from the community and the congregation of Harlem Baptist. Donations came from friends, neighbors and total strangers who were moved by the story. Church members cleaned the Dean's home as a surprise during one trip to Guatemala; and Christian singer Steven Curtis Chapman provided a generous grant.

Family and friends also renovated and expanded the house to accommodate the seven active youngsters.

"I never questioned whether we could afford it, or whether there would be enough love to go around, or enough room in the house. Those things I knew God would provide," says Renee. "God has his own timing, and it's not for us to understand. It's just for us to pray our way through, and take it as it comes."

"Everybody's home. We're all together, says Scott. "We'll have bumps, we'll have fights, and we'll have arguments, but we're all under one roof and we can deal with each other now. We're not split."

Just a few weeks after arriving in Harlem the newest Deans were settled into church, school (with the help of the English as a Second Language program in Grovetown Middle) and a new family. A social service agency that checked on the family was perplexed at the report of no adoption-related problems. The truth is, over the past few years, the Deans -- all nine of them -- had a good chance to get to know each other.

Personal Letter from Javier Juarez-Perez, MPA '08:

To all professors, students, staff and friends in Augusta and North Augusta:

Thank you so much for your support and prayers upon the death of my brother,

Salvador Juárez Pérez (September 23, 1983 — December 21, 2008)





Salvador Juárez-Pérez was a biologist, and was just about to present and defend his thesis to obtain his Bachelor's degree at the University of Veracruz here in Mexico. (where I also studied). A month before his accident, he got a teaching position in the middle school level. This is government work, and once you get it no one can fire you. Additionally, he was just starting a second bachelor's degree in law at the University of Veracruz.

In the above photos, he is shown working in the laboratory where he conducted most of his research. He was a fine young man, a hard worker, with strong team-building skills and a high sense of humanity; he was super altruistic. He spent much of his time helping others, no matter what. As a true scientist he spent almost four years working on his project with the only intention of generating useful knowledge for the betterment of society. He was extremely passionate about it. In addition to his studies and research, he took care of our mother (who recently had open-heart surgery), which was a very time-consuming job, but one from which he never complained.

On Monday, Feb. 9, the staff and teachers of the School of Biology at the University of Veracruz joined with the researchers and staff of the Laboratory of Natural Products (one of several laboratories of the Basic Science Institute at the University of Veracruz) to honor Salvador's studies with the posthumous presentation of his degree. On behalf of my brother, I presented his thesis which was added to the library system in recognition of his Bachelor of Science degree. Our large family and many friends attended the event to pay Salvador the honor which he so rightly deserved.
