[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On November 7th 2012 I responded to 4008 Sugarcane Creek Run

The mother punishes victims by making them wear urine soaked diapers on their heads while standing on their hands. They are made to be naked during the punishment and are in this position for an extended duration. The children are force to run until they vomit and are starved.

Through investigation a photograph was produced by Abuse Reporter. In this photograph you are able to see ✓ and ✓ Jack in what appears to be a push up type position with their feet on the kitchen counter. ✓ hands are on a booster seat and ✓ are on a toy car. AR stated the girls were in this position for 15 minutes. AR advised he told Tiffany the punishment was inappropriate. Tiffany told AR to mind his own business. AR left the residence and came back approximately 2 hours later. ✓ was in this same position when he returned.

Tiffany verbally admitted this was a form of punishment. Tiffany stated she put the girls in this position so she did not have to deal with them. Tiffany's other children and advised this was normal punishment for only ✓ and ✓.

AR also advised, Tiffany would make ✓ and ✓ sit on the toilet days at a time, and strapped to a chair. These bazaar punishments are geared only to ✓ and ✓

The following observations were made on ✓ A large bruise was in the center of her lower back going into her buttocks. The bruise appeared to be new but also had old scars. Next I took a picture of ✓ lower right side were a bruise which appeared to be made by fingers was located. There was a bruise on ✓ left side of her knee. ✓ did appear to be slightly under weight in my opinion. I was able to see ✓ ribs as she stood without her shirt on. then took her shoes off and showed me her feet. The tops of her feet did appear to be swollen. It is my belief this swelling came from the repeated act of her feet being in the push up position on the counter top. There were also multiple scars around her ankles. The skin was peeling off the tips of her big toes.

The following observations were observed on ✓. What appeared to be a recent bruise on the top right of her head. ✓ also had a bruise on her face which began from under to left eye over to her right eye. On the back of ✓ neck was what appeared to be a friction burn which was in her hairline. Another one of these marks was on the left side of her neck. ✓ had multiple small bruises under her belly button and on her back. There were multiple bruises all around her buttocks and her upper left leg. ✓ had the same swelling and scars on her feet as ✓ did.

Due the above stated information. The Defendant Tiffany Jack is found to be in violation of FSS: 827.03.2b, Aggravated Child Abuse and 827.03.1b1, Child Abuse. The defendant has done so by using bazaar punishment to cause mental and physical harm to ✓ and ✓ Jack. During another incident directed towards ✓ Jack the defendant strung her up to a tree. The defendant did this willfully and maliciously caging her child as punishment. These incidents caused bruising all over the children's bodies.

This incident did occur within the city limits of Niceville, Okaloosa County, Florida.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 11/16 /2012, an arrest warrant for Tiffany Jack and a search warrant for 4008 Sugarcane Creek Run (Tiffany's residence) were signed by the honorable Judge Brown. The above mentioned warrants were served and executed at 4008 Sugarcane Creek Run, in Niceville Florida on the evening of 11/16/2012.

Lt Col Dennis Jack (Tiffany's spouse) answered the door and did not attempt to resist Law Enforcement Officers. Tiffany (Mom) walked to the door and was arrested for Aggravated Child Abuse. Tiffany was transported to the Niceville Police Department for processing.

The Miranda Warning was read to Lt Col Jack from a card issued by the Niceville Police Department. Lt Col Jack refused to answer question without a lawyer.

During forensic interviews with the children of Tiffany and Lt Col Jack (Dad) it was learned that Dad was also involved in the punishments, which mom was arrested for.

One of the Jack' children reported the 'calisthenics punishment' (placing the toes on the kitchen counter; holding their own weight with their hands on a pink car, while reportedly wearing a soiled diaper on their head for 15 minutes) was "dad's idea" and "dad said it actually makes you stronger".

Another of the Jack' children called it the "Pink car punishment" (calisthenics); she stated "he (dad) used to put them (Victim 1 and 2) up"; and added "he does everything the same as mom".

A third child advised about spankings; she stated the parents (both) "use a hand or a spoon"; and further stated "they only use it one time and then they use a spatula". The child stated "spatula hurts" and then she described it as "the metal one" that is "silver". The child reported that this punishment (spatula) is done to the adopted children (Victim 1 and 2) on the tops of their feet.

The children identified Dad as having knowledge and participating in the acts of Child Abuse.

One of the children later provided information that Dad trained them (three of the Jack' children) on "interrogation" techniques prior to their (forensic) interviews. Another child advised "they (mom and dad) don't want us to talk about the bad stuff".

This officer has reason to believe and does believe Lt Col Jacks did commit the offense of Child Abuse F.S.S. 827.03.1b; an act that could result in physical or mental injury, and did also commit the offense of Obstructing Justice F.S.S. 914.22.1; by tampering with the victims. These offenses did occur in the City of Niceville, Okaloosa County, Florida.
