[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 11/16/2012, an arrest warrant for Tiffany Jack and a search warrant for 4008 Sugarcane Creek Run (Tiffany's residence) were signed by the honorable Judge Brown. The above mentioned warrants were served and executed at 4008 Sugarcane Creek Run, in Niceville Florida on the evening of 11/16/2012.

Lt Col Dennis Jack (Tiffany's spouse) answered the door and did not attempt to resist Law Enforcement Officers. Tiffany (Mom) walked to the door and was arrested for Aggravated Child Abuse. Tiffany was transported to the Niceville Police Department for processing.

The Miranda Warning was read to Lt Col Jack from a card issued by the Niceville Police Department. Lt Col Jack refused to answer question without a lawyer.

During forensic interviews with the children of Tiffany and Lt Col Jack (Dad) it was learned that Dad was also involved in the punishments, which mom was arrested for.

One of the Jack' children reported the 'calisthenics punishment' (placing the toes on the kitchen counter; holding their own weight with their hands on a pink car, while reportedly wearing a soiled diaper on their head for 15 minutes) was "dad's idea" and "dad said it actually makes you stronger".

Another of the Jack' children called it the "Pink car punishment" (calisthenics); she stated "he (dad) used to put them (Victim 1 and 2) up"; and added "he does everything the same as mom".

A third child advised about spankings; she stated the parents (both) "use a hand or a spoon"; and further stated "they only use it one time and then they use a spatula". The child stated "spatula hurts" and then she described it as "the metal one" that is "silver". The child reported that this punishment (spatula) is done to the adopted children (Victim 1 and 2) on the tops of their feet.

The children identified Dad as having knowledge and participating in the acts of Child Abuse.

One of the children later provided information that Dad trained them (three of the Jack' children) on "interrogation" techniques prior to their (forensic) interviews. Another child advised "they (mom and dad) don't want us to talk about the bad stuff".

This officer has reason to believe and does believe Lt Col Jacks did commit the offense of Child Abuse F.S.S. 827.03.1b; an act that could result in physical or mental injury, and did also commit the offense of Obstructing Justice F.S.S. 914.22.1; by tampering with the victims. These offenses did occur in the City of Niceville, Okaloosa County, Florida.
