2010 DELEGATION TO THE UNITED KINGDOM AND ETHIOPIA

On August 31 – September 4, 2010 a delegation of U.S. government officials and private business leaders participated in a fact-finding trip to London, United Kingdom and Addis Ababa, Ethiopia. As with all 20/20 vision efforts, this trip was the direct result of partnership between CCAI and public and private organizations who share our mission.

The delegation, led by U.S. Senator Mary Landrieu (D-LA), included recently appointed Special Advisor on Children's Issues, Ambassador Susan Jacobs and Gary Newton, U.S. Government Special Advisor for Orphans and Children (U.S. Agency for International Development).

THE UNITED KINGDOM

The delegation spent its first day in the United Kingdom discussing global orphan issues and the desire to encourage transatlantic collaboration among partners in the United States and the United Kingdom.

UK Itinerary

In Mayfair, London, Senator Landrieu met with Members of Parliament, Mr. Jim Fitzpatrick and Mr. Nick Smith, about the work of the nearly 200 Members of the Congressional Coalition on Adoption, where she serves as Senate Co-Chair, as well as that of the Congressional Coalition on Adoption Institute. Discussions also included the need for transatlantic partnerships between the two governments' legislative bodies to focus on orphan policy throughout the world, and the importance of uniting to reach common goals on behalf of children in need of permanent families.

The delegation then attended a program hosted by the Legatum Institute. The group also briefly toured the Foundling Museum in London. The Museum is located next to the original property of the Foundling Hospital, London's first home for abandoned children (founded in 1739) and showcases the history of the up to a thousand babies abandoned every year in 18th-century London and the progress made in improving their care and outcomes.

ETHIOPIA

Over the four days spent in Addis Ababa, Ethiopia, the delegation met with officials of the U.S. Mission to Ethiopia, Ethiopian government leaders, and key stakeholders in the Ethiopian orphan crisis. They also had the opportunity to make several field visits focused on demonstrating both the need and current response to orphan issues in Addis.

Ethiopia Itinerary

The delegation's time in Ethiopia included visits to the Buckner Bright Hope Assessment Center and Community Transformation Center, as well as a ceremony attended by the organization's 500 foster children and their These programs highlighted how private, parents. Ethiopian-led not-for-profit organizations, established through support of private international organizations, can provide quality services designed to strengthen and support children in families. The delegation also visited Buckner Bright Hope's Elementary School in Bantu, a rural community two hours outside Addis and the home area of Ethiopian President Girma Wolde Giorgis. There the delegation observed the 400 school children enrolled at the school and engaged in a discussion with many of their families, as well as the elders of the town.

The delegation visited two different orphanages – the Government of Ethiopia's 'Kebebe Tsehay' Orphanage for younger children, and the Missionaries of Charity Orphanage and Family Center which is run by Mother Theresa's Order of Nuns. Like so many of their counterparts, both orphanages reported struggling with lack of resources and staff to fully care for the children's physical needs.

The delegation also met with representatives from the Embassies of France, Italy, Spain and Belgium, as well as UNICEF Ethiopia to discuss the role of intercountry adoptions of children from Ethiopia and to strategize about how to address identified areas of concerns with the current process. In addition, delegation members were asked to participate in a roundtable, hosted by USAID and UNICEF Ethiopia, which brought together panelists from the full continuum of care for orphaned children in Ethiopia – ranging from institutional care, child protection, reunification, foster care, domestic adoption, and intercountry adoption.

Interactions with the Government of Ethiopia were warm and fostered positive dialogue. His Excellence, President Girma Wolde Giorgis hosted the delegation and representatives from the U.S. Mission and UNICEF at a banquet in his home, the National Palace. Foreign Minister Seyoum Mesfin also hosted the same group for dinner at an Ethiopian restaurant.

OUTCOMES

UNITED KINGDOM

CCAI hopes to continue the momentum towards building a transatlantic, strategic partnership between Members of Congress and Parliament. Toward that end, CCAI was honored to be asked to consider hosting a delegation of Members of Parliament for a visit to Washington, D.C. for continued in-depth discussions with a larger representation of Members of the Congressional Coalition on Adoption. In addition, CCAI plans to continue to work with the Legatum Institute and the EACH Campaign to promote global awareness of and best-practices in orphan, foster care and adoption policies in the U.S. and U.K.

ETHIOPIA

The delegation came away from this visit to Ethiopia with the confidence that the foundation for a relationship with the Ethiopian child welfare officials has been laid. They were encouraged by the obvious enthusiasm and skill demonstrated by those in charge of reforming the laws and programs affecting orphaned children.

Ministry Leadership on Implementation of the Hague Convention on Inter-Country Adoption

Prior to the delegation's visit, the Ethiopian ministries had disagreed upon which had authority over intercountry adoptions. As a result of the discussions the delegation participated in with the Ministries, the Government of Ethiopia has officially acknowledged that the Ministry of Women's Affairs has the appropriate jurisdiction and can be designated as Central Authority for the purposes of implementing the Hague Convention.

Working Toward Hague Convention Accreditation and Hague Standards for Foreign Adoption Service Providers

Prior to the delegation's visit, UNICEF and the U.S. Embassy had been in discussions with the Government of Ethiopia about moving toward implementation of the Hague, with hopes that the process of implementation might begin within the next year. This continues to be something these entities will strive toward together, but in the interim, delegation discussions of the need to protect Ethiopian children and families against fraud or corruption in intercountry adoptions led to a decision that Ethiopia will soon require <u>all</u> foreign adoption service providers to be accredited under Hague standards, thus lowering the likelihood of agencies partaking in questionable or fraudulent practices.

U.S. AID Task Force

Since the delegation, USAID Ethiopia has begun working on the foundation for a USG task-force on children's issues in Ethiopia. Under consideration for the roles of this task-force are the following possibilities:

- Expanding PEPFAR partners' capacity and programs to reunify street children with their families or place children with new families under kinship or foster care;
- Working to align USAID's current assistance with the goal of strengthening Ethiopia's national child welfare system and to implement Ethiopia's new alternative care standards;
- Facilitating the growth of public-private partnerships in Ethiopia
- Integrating programs and mobilizing private sector resources;
- and identifying current U.S. Government partners and programs that can, within existing contractual parameters, work in HIV/AIDS-affected communities to support the implementation of GOE policy to transition children from institutional care to permanent family care.

CCAI is greatly encouraged by the strengthened relations, new partnerships, and enthusiasm of all partners engaged in both the United Kingdom and Ethiopia through the 20/20 Vision Program delegation, and looks forward to continuing to work with British and Ethiopian leaders and the U.S. Government to achieve these goals.
