And then they are going to NAIL the new family with post adoption follow-up costs? Those people are beyond unscrupulous.. I can see where social worker needs more guidance in what she is doing. She is signing as MSW, not LCSW-C. LC takes 3000 hours of supervision post masters and a hellish exam that many people flunk the first time around.

As for Julie I can't help but wonder what this girl was doing in Spain. I also wonder about the 2 adult male cousins in the household of ex-mom and I do wonder if the "brother" is truly the father or if she is covering up for someone else.. Nothing would surprise me. Someone In Ukraine knew all about this girl yet they allowed ex-mom to adopt her without disclosing all of it. I have my doubts about 5 males raping her since she would have needed hospitalization after something like this. It is unlikely to have happened the way she says unless she was in a child brothel in Spain. That would explain quite a lot, including her return. Child exploitation in Ukraine is big business. EC and myself have been tracking a Ukrainian kiddie porn site. I reported the site to the domain registrar. If they do not shut them down I will find people who will DOS the bastards out of existence. Julie has a lot more to tell then she is telling.

I have to say my feeling is this maternity home, Jill Rufus and the rest of them are doing a lovely job brainwashing this kid and I really do not feel they have her best interest at their greedy little hearts.

I know you and I probably differ in our opinions of this but I feel that countries that deliberately do not supply adoptive parents with information about the kids should take the responsibility for the kids when adoption fails. If US and social system's of other countries keep bailing out Ukraine, Russia, Byelorussia and others by taking on the burden of carrying for those unfortunate kids two things will happen:

- 1. Our already inadequate foster care system will be so overwhelmed that it will negatively impact kids already in it
- 2. Those other countries will not learn to care for their own and will not take responsibility. The result will be increase in homeless and exploited kids.

It saddens me terribly that those things go on. All we can do is keep exposing the lies and keep trying to teach others who are looking to adopt and show dangerous naïveté about the future.

I cannot believe that CH is still keeping the picture of this unfortunate family on her website just for the sake of keeping drumming up business. It is not only is bad taste but it also easily identifies this young girl to the world for years to come.....

Was Julie adopted by the family in Spain and then did they disrupt her adoption and return her to Ukraine? I had heard about this happening once with a girl from Romania, adopted at age 3 and living in Greece, then disrupted at age 5 and returned to Romania, my husband and I viewed her video when she was available for adoption at age 8 through Adopt an Angel in 2001. If so, why? If not, was she in Spain for summer/holiday programs similar to Kidsave, etc...?

Is it my understanding that your agency already has an adoptive family for the baby and that Julie agrees/is comfortable with this? When is the baby do? Julie is very young and petite, how is she holding up through this pregnancy and I imagine her pregnancy is considered "high risk" and good care is being given?

After the baby is born, will there be a paternity test to determine if indeed the adoptive brother is the biological father of the baby? This "brother", the baby's "father" is being sent back to Ukraine if no new family is found to adopt him very soon? Are you handling his case also? If not, if I think of a family that may wish to adopt him, who should I have them contact? I have too many little girls to even consider a situation like that, it would be unwise, too risky. Are the other brothers still in country - with "Ann" or elsewhere and would Julie want any contact with them/would a new family be advised /expected to do so?

As for Julie, from what was written she seems like a bright girl. Does anyone know for sure exactly what has happened with her sexually over the years - what is true and what is not? Does she exhibit any sexual behavior towards younger children - girls or boys or adults - grown men? Is it believed she has been sexually active with other boys her age

here in the U.S. not in her household? What was the situation with the male "cousins/uncles" living in the household? Who and how was it determined she was(is) pregnant? Was that the only time she displayed the "homicidal" incident?

What would the procedures and costs be for her adoption? I imagine Julie would have final say in this - whether she wants to go to a family or not? Or is she just so frightened of being returned to a Ukrainian orphanage that she would do anything to stay here?

Do the "experts" on her case consider it risky for her to be in a home with a boy close in age to her?

What happens if she gives birth and changes her mind and decides to keep the baby?

I assume the prozac was for depression, how about the depacote? Was it for aggressive behavior? other?

We recently moved to a very nice neighborhood of more of a city (from the country) as the population is very diverse and there is a big population of eastern europeans. We belong to the congregational church right down the street. Very nice people there. The high school my husband works at also has a large Ukrainian population. I know we could be good parents for Julie but I wonder if we are the best and safest answer since we have 5 children already. Also, financial concerns.
